

NOTIFICATION

The Governor of Arunachal Pradesh is pleased to accord approval of decision taken in the Cabinet Meeting held on 10.08.2018 as shown below:-

- a. All the out of turn appointees/promotes in the Education Department are to be revoked with immediate effect. This is to boost the morale of deserving in service, officers and employees and to streamline the system.
- b. Organization restructuring of the Department of Education including Recruitment Rules review/ amendment for all the posts at all levels is to be undertaken in a time bound manner.
- c. Many Schools in the past have been upgraded rampantly without proper analysis, development of infrastructure and creation of Post. At the same time there are schools which require up gradation for long. An extensive exercise is to be conducted for up gradation of schools as per requirement in all the districts.
- d. There are 254 Elementary Schools and 19 Secondary level schools having Zero enrolment as per UDISE 2017-18 data with 148 teachers and 34 teachers posted in the said elementary schools respectively. All such Zero Enrollment Elementary Schools need to be closed subject to verification by the district concerned by 31st August 2018. All the teachers from such schools will be redeployed in teachers deficit schools after due verification. The Zero enrolment Secondary Schools will be declared as Govt. Upper Primary Schools. The surplus teachers posted there will be adjusted accordingly.
- e. For Class XII and X, Half Yearly exam is to be conducted in the month of September and Pre-board examination in the month of January every year. Only those who secured minimum 33% in Pre-board may be allowed to appear in CBSE and minimum 80% attendance, otherwise the students may be debarred.
- f. School management Committees (SMCs) are to be revamped and reconstituted as per the present norms for proper functioning of the schools.
- g. Academic session should be strictly started with effect from 1st April every year so that by 1st June admissions are done & Text books procurement / distribution is done and holiday home work is also assigned to students to utilize the time period.
- h. Transfer of all beneficiaries' grants such as stipend / scholarship / Vidya scheme / Girls Hygiene etc to be done through DBT only.
- i. NGOs extending their cooperation in the field of education, free of cost should be encouraged.
- j. The idea of only one Director of School Education for effective implementation on the lines of ISSE should be examined.
- k. State Education Advisory Council as per section 106 of Arunachal Pradesh Education ACT 2010 should be revamped.
- l. Post creation exercise for Yoga Instructor / PET / Music Teacher / Special Educator should be initiated.
- m. No tobacco, alcohol shop should be allowed within the prescribed periphery of a school.
