4. The concerned school authorities will be required to provide a copy of the Tentative Calendar of School Activities of their schools to the DDSE and DSE / DEE.
5. Further each Head of Schools has to circulate the Guidelines cum undertaking to each student on 1<sup>st</sup> April 2019 itself and get back signed undertaking by each student and her / his parents by 8<sup>th</sup> Apr 2019 for office record.

Therefore, the DDSE's are requested to circulate the Calendar of Activities to all the Schools in their District.


