**NOTIFICATION**

The Govt. of Arunachal Pradesh is pleased to accord approval of Examination fees for the appearing students/candidates from Private Aided/Unaided recognized schools of the State of Arunachal Pradesh for the Arunachal Pradesh State Board Examination for Class-V and VIII (APSBE) as follows:-

1. The rate of Examination fee per candidate/student of Class-V and VIII studying in the Private Aided/Unaided recognized schools of the State of Arunachal Pradesh for appearing the Arunachal Pradesh State Board Examination for Class-V and VIII (APSBE for Class-V and VIII) is Rs **750/- (Rupees Seven Hundred Fifty)** only per session.
2. The Examination fee shall be in force with effect from the academic session 2019-20 and valid till it is re-fixed specifically.
3. The Private Aided/Unaided recognized schools of the State of Arunachal Pradesh should deposit the Examination fees against the number of appearing candidates in favour of Director of Elementary Education, Govt. of Arunachal Pradesh Itanagar through Treasury Challan in the "Head of Account -0202".
4. A copy of Treasury Challan from each school against the number of enrolment should be submitted by the Private Aided/Unaided recognized schools concerned to the office of the Dy. Director of School Education at District for maintaining record and proper scrutiny.
5. The consolidated Examination fees collected within the District in Treasury challan should be forwarded to the office of the Directorate of Elementary Education, Itanagar by the DDSE concerned.
6. The Examination fee shall be levied from the students of Class-V and VIII for appearing the Arunachal Pradesh State Board Examination for Class-V and VIII only.
7. The Examination fee shall be levied to the students/candidates of Class-V and VIII from Private Aided/Unaided recognized schools of the State of Arunachal Pradesh only.
8. The last of Date of submission of Examination fee is 31<sup>st</sup> Oct every year but for academic session 2019-20 is 30<sup>th</sup> January 2020 (**Thursday**).

This has got approval of competent authority vide U.O No. 50 dtd 17/12/2019.




